# **FIELDS OF APPLICATION**

VORMIOL EMM10 is an economical form release agent for the universal use in concrete applications. The product is suitable for precast and pipe concrete as well as for construction sites.

The high-efficient product is versatile and allows the application on the following substrates:

- Steel forms and moulds
- Plastic forms and moulds
- Wooden forms and moulds

# **APPLICATION QUANTITY**

Depending on the surface structure and its absorbing abilities the necessary amount might vary between 100 - 240 g/m<sup>2</sup> and has to be determined for each single application.

# WORKING PRINCIPLE

VORMIOL EMM10 works chemically/physically. It provides very good adhesion to the formwork and simplifies the separation between concrete and the formwork.

## **PROCESSING INDICATIONS**

Surfaces of formwork should be dry, clean and free of loose particles. Contaminations have to be completely removed.

VORMIOL EMM10 is a ready-to-use agent and should be applied evenly to the complete surface in order to form a homogenous coat on the formwork. A suitable spraying system should be used.

Stirring up, circulation or agitation is recommended before applying the product.
