PANTARHIT® RMC 276 may reduce the compaction energy applied to concrete. Concrete manufacturers, contractors and applicators may therefore achieve an economical and technical benefit.

DOSAGE

Recommended dosage range 0.2 - 3.0 mass-% of the cementitious content.

PANTARHIT® RMC 276 improves the cement dispersion within the concrete significantly. This property allows the formation of a homogenous and low-viscosity cement paste which ensures an improved workability and facilitates the compaction of concrete.

COMPATIBILITY

PANTARHIT® RMC 276 is suitable for concrete designs containing OPC or SRC cement, microsilica or silica fume, fly ash (PFA), ground granulated blast furnace slag (GGBS).

PANTARHIT® RMC 276 should not be used in conjunction with any naphthalene-based admixture.

When using other Ha-Be admixtures in the same concrete mixture, the products should be added separately and must not be blended prior to addition! Using more than one admixture requires suitability and preliminary tests to ensure the required combination of its effects is attained.
